



# Textiles Ecosystem Transition Pathway

## Introduction and agenda

We are pleased to invite you to the first thematic webinar of EU Textiles Ecosystem Platform, “**TCLF resilient value chains in times of crisis**”, which will take place **online** on **28 April 2026** at **10:00-11:30 CEST**.

The textile, clothing, leather and footwear (TCLF) value chains across Europe are under growing pressure due to overlapping crises such as geopolitical instability, supply chain disruptions, rising costs, and evolving regulatory and market conditions. These challenges have highlighted the need for greater resilience and adaptability across the sector.

The webinar aims to facilitate exchange on how industry actors are responding to these pressures and strengthening the resilience of their value chains by addressing key challenges for the TCLF industry. A keynote will set the scene, followed by three best-practice presentations from EU-based companies showcasing innovative approaches to resilient value chains.

The workshop is organised by the project team (activity lead by ITA Technologietransfer GmbH).
